System Updates

You Spoke, We Listened!

Over the past few months, you may have noticed updates to the **Evvie app**, **Evvie portal**, **Participant Dashboard** and the **ESS Portal**. Many of these improvements came directly from your feedback—through the **Participant Advisory Group (PAG)** and the **annual satisfaction survey**.

Here are just a few of the exciting changes:

EVV Tools (Evvie App and Evvie Portal)


- **Seconds Added to the Evvie App:**
Now your DCW can see hours, minutes *and* seconds—so they know exactly when they clocked into their shift.
- **New Log Out Icons in the Evvie App:**
Clearer icons make it easier to log out with confidence.
- **Offline Mode in the Evvie App:**
Your DCW can clock in/out without internet. Once reconnected, shifts upload automatically.
- **Cleaner Evvie Portal Views:**
We simplified the layout to make information easier to read.
- **Bulk Approvals in the Evvie Portal:**
Approve multiple shifts at once—no more one-by-one!
- **Email Notifications:**
You can now opt out of notification emails if you prefer.

Participant Dashboard Enhancements

- **Weekly Usage Tracking:**
See your weekly hours and expected run out date based on current usage.
- **Max Pay Rate Displayed:**
Easily view the maximum pay rate for your DCWs. Check this regularly for updates.
- **DCW Good to Go Date:**
View your DCW's Good to Go Date.
- **DCW Pay Rate:**
View your DCW's current hourly pay rate.
